To enter Mexico: Bring a passport (only item required); a copy of your passport, an official copy of your birth certificate and a valid photo identification (not required, but a good backup in case something happens to your passport)

To return to the USA: Bring a passport, an official copy of your birth certificate and valid photo identification. If you have a "Green card", YOU MUST BRING THE ORIGINAL. (There is a \$170 fine for not having your original Green card.)

All other Nationalities Must

To enter Mexico: Call the nearest Mexican Consulate for permission to travel into Mexico. There are some nationalities that are excluded from entry based upon diplomatic relations. Check the internet or the Los Angeles Consulate General of Mexico:

(213)351-6800 (They answer the phone in Spanish. If you need to, you may ask to speak to someone that speaks English.)

To return to the USA: You must have a visa and Passport that allows re-entry into the USA. If you have a "Green card," YOU MUST BRING THE ORIGINAL. (There is a \$170 fine for not having your original Green card.)

Consent to Travel Outside the United States to Mexico: The above-named Parents or Guardian of the Team member has entrusted the Team Member into the care of the Agent, an adult, and a duly authorized representative of the Organization, while the Team Member participates in "Mexico Missions Trip," an activity of the Organization.

The Parent or Guardian does hereby authorize the Team Member to travel outside the United States to the nation of Mexico.
